Please call for an appointment before returning an instrument. Do not leave instruments unattended on our doorstep or at school. You are financially responsible for their safe return into our hands.

The instrument, case and bow (outfit) rental term will run for a period of three months. No partial refunds will be given. The rentee is not obligated to renew the contract and may return the instrument at the end of each term. Payment is due on or before the first day of the term. A reinstatement fee of \$10 per month will accrue on all payments more than 7 days late. To cancel the contract, the rentee must notify MUSICOOOL of this intent at least two weeks before the beginning of the rental quarter and must be responsible for the safe return of the outfit to MUSICOOOL by the last day of the rental quarter for which they are renting. The contract will begin on the first of Oct, Jan., Apr. or Jul. Instruments rented between those times will have an adjusted first payment to place them on the rental schedule. A switch to a different instrument offered by MUSICOOOL will be considered a continuation of the original contract and will be covered by the terms of this contract.

The instrument outfit does not include a stand, tote bag or book/CD. These are separate items that may be purchased outright and then you will own them and not be billed for them in the future.

The outfit provided by MUSICOOOL will remain the property of MUSICOOOL at all times. The rentee agrees to properly care for the instrument and to return at the conclusion of the rental term it in the same condition as when rented. The rentee is financially responsible for any damage done to the outfit as well as for the replacement cost of any part of the outfit if it is stolen or lost. The rentee is responsible for any harm that may come to any property or a third party or parties due in any way to the outfit.

All damage done to the outfit that is not caused by negligence as determined by ADOS will be repaired or replaced without cost to the rentee as long as the rentee has paid for damage insurance and is current on billing. The policy does not cover replacement of stolen or lost instruments nor does it cover the cost of replacement strings.

The rentee is responsible for all account collection fees on accounts that are more than 30 days past due.

The rentee gives MUSICOOOL permission to charge to his or her credit/debit card rental and late fees plus a \$10 processing fee and reinstatement fees on any payment not received by the seventh day after its due date.
